Motion was in order to accept the previous minutes and treasurers' report as printed and distributed. Motion by Commr Friemann, seconded by Commr Fisher, motion carried unanimously.

#### **Correspondence:**

Letter received from Maria McBride, event coordinator, for a fund raiser for Gerry Hayden to be held on Sunday October 13, 2013 adjacent to District Property on Cox Lane. She is requesting use of our land to the North to park cars for the event. Attached is the certificate of liability insurance in amount up to 2 million dollars. Following a brief discussion a motion was offered by Commr Fisher, seconded by Commr Friemann, motion carried unanimously.

#### **Commissioners' reports:**

Commr Brewer informed that repairs were made to the rear of firehouse walk and window wells for \$3200.00. Boat Dock repair in New Suffolk is in progress. Budget hearing for the proposed 2014 budget is to be held on October 15<sup>th</sup> at 7 PM.

Commr Fisher stated that he has added two additional persons to our employee list. He also noted that the surveillance system recorder has failed and new replacements are being quoted. Also he is considering use of the key fob system for alarm attendance. The NFPA has printed a guide book for electric cars and a PDF is also available for this information. A copy of the book and the PDF was purchased and will be installed for the officers' use.

Commr Fogarty mentioned that he is having hydrant signs repaired and new ones installed. He went on to say that the district has various policies that will be effective soon and the do's and don'ts should be followed by all members.

Commr Zuhoski, 8-5-7 wires burned and repaired, 8-5-3 Deck Gun is also being repaired at Firematic Co., 8-5-16 is returned to service following and accident and the 8-5-23 car was detailed by member Chris Voegel and a letter of commendation should be sent. Commr Zuhoski also commented that the BBQ was run very well and passed his appreciation to the United Fire Company.

Commr Zuhoski then noted that the Company room in the south wing has not been redecorated in 20 years and thinks that this should be considered by the board.
